पूर्व विधायक झोटेराल सरावगी और नगर परिषद बुडार की अध्यक्ष शालिनी सरावगी के पति पुत्र नगर पंचायत उपाध्यक्ष राजा सरावगी को चर्चिता पुलिस ने गिरफ्तार कर लिया है। चर्चिता थाना प्रभारी सीपी सिंह ने बताया कि कोयले की हेराफेरी के मामले में जुलाई 2015 से चर्चिता राजा सरावगी उमरिया न्यायालय में
